Running of the Bar at the 2018 Longreach Show

(Friday 18th to Saturday 19th May 2018)

The Longreach Show Society Inc. is calling for expressions of interested from suitably qualified and capable local community groups for the running of the Bar at the 2018 Longreach Annual Show, with the possibility of offering an extended 3-year term.

Longreach Show Society (LSS) will provide:

- LSS will apply and hold an appropriate Liquor Licence permit including completing the Alcohol Management Plan for the duration of the Show.
- LSS will source and purchase alcohol supplies for the Show event.
- LSS will supply security in liaison with the successful tenderer.
- LSS supply cups, bar tickets and set the bar prices.
- LSS will supply the float and cash tins.
- The successful tenderer will be paid a fixed rate of \$5000 per year for running of the Bar.
- LSS will offer a 3-year term for the running of the Bar based on performance of the successful tenderer in their first year (2018).

The successful tenderer will be required to:

- Ensure prompt, efficient and high-quality bar services throughout the duration of the Show.
- Pick up, check order and pack alcohol/drinks in coldrooms at Showgrounds Bar on Thursday 17th May 2018.
- Set up bar area (Thursday/Friday)
- Co-ordinate a roster and provide sufficient number of bar workers/volunteers to cope with busy periods and provide well-organised customer service.
- Sell alcohol (cash and bar ticket system) between hours designated by Licence and LSS (Friday night, Saturday and Saturday night – times TBC with successful tenderer).
- Supply eskies and nip pourers
- Follow directions from LSS/Police and adhere to Liquor licencing requirements/laws as required
- Clean up bar area and remove rubbish following Show (Sunday)
- Stocktake and return unused/unopened alcohol to supplier (Sunday or Monday)
- Ensure a minimum of two current RSA (Responsible Service of Alcohol) holders are working in the bar at all times during peak periods. Times TBC with successful tenderer.
